## Bungalow Bounce

### Full Release of Liability and Waiver Form

Each participant must have a waiver form signed, either by a parent/legal guardian or designated representative by parent/guardian. I, for myself, my child, ward, or the minor(s) named below, agree, acknowledge and understand that there are dangers and risks associated with the activities at/by Bungalow Bounce and agree to assume all risk of personal injury, including the potential for paralysis and death. I also agree to pay for all damages to the facilities of Bungalow Bounce caused by myself or the listed minors' negligent, reckless, or willful actions. In addition, if I observe any hazard during our participation, I will bring it to the attention of the nearest Bungalow Bounce staff member immediately.

"Rules of Play" include, but are not limited to (1) socks must be worn (no shoes or bare feet) in the play area (inflatables, games). (2) Adults must supervise their children at all times unless a designated special event is taking place where adult supervision is not necessary.

This waiver and release shall be binding and apply to all risks, known and unknown, even if resulting from negligent actions of other guests.
